

ABOUT US

We are running a center at Anna Nagar, Chennai, since March 2019, to educate, train and empower children and young adults in the age group of 6 to 30 years, with disabilities like intellectual disability, Autism, CP (with independent mobility), Downs Syndrome and multiple disability.

We started with five students and are presently providing services to fifty students.

For students between the age group of 6 to 18 years, we are providing basic education, pre academics, self help skills like eating, drinking etc., communication, social skills, yoga and sports for physical well being. For students who are able to cope up with academics, we are enrolling them into non formal education through open schooling.

Until now around 15 students have cleared secondary and senior secondary exams.

For students above 18 years of age, we are providing vocational training, life skill training, sports and yoga for physical well being, employability skills, leisure time activities.

Seven of our students, underwent internship at SHELL outlets for one month under the guidance of job coaches. Four of our students took up an outsourced work for three months at a stabilizer making company. Products like vegetables cut are regularly sold out to the parents and neighbors and the proceeds are given away to the students as stipends.

Our uniqueness is designing curriculum specific to each child, nurturing the talents of each child and taking them forward to the next level and projecting their abilities to the society, and creating some outsourced work to train for employability skills. We have enrolled students with severe behavioral problems, who have been turned down by many other organizations.

M.N. Eye Hospital Pvt Ltd is one of the leading eye hospitals in Chennai with more than 33 years of experience in the field of eye care and has positioned itself as an ethical, compassionate family eye care. It was started in 1986 with an intent to provide quality eye care at affordable cost to the fisherfolk of North Chennai, who had no access to quality eye care. In a short span, they realized that the problem of availing good eye care was a for more complex socioeconomic problem.

Janaki Natarajan Vision Research and Visual Rehabilitation Charities (JNVR) was registered as a Trust (Regn No.449/1988, dated 24-02-1988) to eradicate needless Blindness in the society. There was a certain group of people, who couldn't afford to pay even nominal charges. Thus, was born the idea of a charitable trust right next door to the paying hospital. It served as the charity wing of this hospital, providing completely free consultation and performing cataract surgery free of cost for more than 30 years.

M.N. Eye Hospital Pvt.Ltd have been helping the senior citizens to regain their sight by providing Free Eye Screening and Cataract Awareness Camps in Chennai, Kancheepuram and Tiruvallur districts for the underprivileged and needy senior citizens. Over the past 30 years more than two lakh patients have undergone cataract surgeries free of cost.













5. Executive Summary:

Cataract is a leading cause of blindness in India, particularly among the elderly and economically disadvantaged. The "Project Jyothi" aims to provide free cataract surgeries to 1000 underprivileged individuals over one year, improving their quality of life and raising awareness about cataract prevention and treatment.

6. Background and Justification:

Cataracts account for over 60% of blindness cases in India, disproportionately affecting those in rural and underserved areas. Many cannot afford surgery due to financial constraints. 

<u>Details of contribution towards Corporate Social Responsibility ('CSR')</u> during the year 2024-25

As per the provisions of Section 135 of the Companies Act, 2013, a company meeting the applicability threshold, needs to spend at least 2% of its average net profits for the immediately preceding three financial years on CSR activities. As a result, it was required to adhere to the provisions of Section 135 of the Companies Act, 2013, which includes fulfilling obligations related to CSR activities for the financial year 2024-25. Hence, the Annual report on CSR was not applicable for the FY 2023-24 and consequently, CSR provisions was applicable to the Company starting April 1, 2024, based on the profit recorded for FY 2023-24.

The Company has reported Average Net Profit of Rs.4,73,13,424/- as computed under Section 198 of the Companies Act, 2013 for the financial years 2021-22, 2022-23 and 2023-24 and two percentage of it amounting to Rs.9,46,268/- rounded off to Rs.9,50,000/- required to be spent.

Brief outline on CSR Policy of the Company

The Board of Directors (the "Board") of Taiyo Feed Mill Limited ("TFML") has adopted the CSR policy which has following objectives:

- a) ensure an increased commitment at all levels in the organization to operate in an economically, socially, and environmentally responsible manner while recognizing the interests of all its stakeholders.
- b) directly or indirectly take up programs that benefit the communities in and around our work locations and result, over a period of time, in enhancing the quality of life and economic well-being of the local populace.
- c) generate, through our CSR initiatives, a community goodwill for Taiyo Feed Mill Limited and help reinforce a positive and socially responsible image of Taiyo Feed Mill Limited as a corporate entity.

The following two areas were identified by the management for the contribution of CSR Funds during the year under review, namely;

- (i) Gurukulam Trust for Children with Special Needs, a school registered for educating, training and empowering children and young adults in the age group of 6 to 30 years, with disabilities like intellectual disability, Autism, CP (with independent mobility), Downs Syndrome and multiple disability., and holding CSR Certificate received from 'Ministry of Corporate Affairs' (MCA) bearing Registration number CSR00043301.
